### 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

## **6. ACCIDENTAL RELEASE MEASURES**

#### **SMALL SPILLS**

## **LARGE SPILLS**

If safe to do so, shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Recover by pumping with explosion-proof pump or hand pump or with a suitable absorbent material (soil, sand or other inert material). Use a spark-free shovel. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.
