#### 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

#### SMALL SPILLS

#### LARGE SPILLS

Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Recover by pumping – use explosion-proof pump or hand pump – or with a suitable absorbent material (soil, sand or other inert material). Use a spark-free shovel.
